

FVR—PCA OFFICERS AND DUTIES

Article VIII - Officers and Duties

Section 1 - Officers

The elected Officers of the club shall be the President, Vice-President, Secretary, and Treasurer, all of whom shall be considered members of the Executive council.

Section 2 - Duties of the President

The duties of the President of the club shall be:

- a. To prepare the agenda for and preside at all meetings.
- b. To act as ex-officio member of all standing committees except the Nominating Committee or as otherwise excepted herein.
- c. To appoint committees necessary for the proper function of the club.
- d. To execute all documents and correspondence in the name of the club as authorized by the Executive Council and/or the membership.
 - To sign all drafts on the accounts of the club and any documents which obligate the club.
 - f. To publish in the club's official publication a report on the status of the club, its plans and programs.

Section 3 - Duties of Vice-President

The duties of the Vice-President of the club shall be:

- a. To preside at meetings in the absence of the President or when ordered to do so by him.
- b. To assist the President in the conduct of the administrative affairs of the club.
- c. To perform such other duties as may be assigned to him by the President or by the Executive Council.
- d. To obtain the plaques, awards, and trophies that are presented to club members.

Section 4 - Duties of Secretary

The duties of the Secretary of the club shall be:

- a. To record and preserve the notes of all meetings of the membership and Executive Council and of all votes cast thereat.
- b. To publish notes in the newsletter.
- c. To receive all ballots, count them, cause to be published the results thereof and keep them for inspection for a period of thirty (30) days after the results are announced.
- d. To publish in the club's official publication notices of proposed and adopted amendments of the Articles of Incorporation and these Regulations and other matters relating to the proper conduct of the club.

Section 5 - Duties of the Treasurer

The duties of the Treasurer of the club shall be:

- a. To record and preserve the records and books of account reflecting the financial condition and operation of the club.
- b. To have custody of all monies, debts, obligations and assets belonging to the club.
- c. To receive all monies of the club and deposit them to the club account in a bank insured by the FDIC
- d. To sign all drafts on the accounts of the club and any documents which obligate the club.
- e. To publish in the club's official publication a report on the financial status of the club.
- f. To give a full and correct report on the financial status of the club at any meeting of the membership or Executive council.
- g. To insure that the financial affairs of the club are in accordance with the National Club Bylaws and all pertinent legal guidelines regarding same.






600-MILE FVR FALL TOUR

Fox Valley Region's "Circle" Fall Tour

A flotilla of ten Porsches crossed Lake Michigan on the *S.S. Badger* car ferry from Manitowoc, WI, to Ludington, MI, on Friday afternoon, September 14. It seemed a bit unusual for the Fox Valley region's 7th annual fall tour to begin on water, not land, but twenty adventurous members were taking the "short cut" to Michigan for the weekend. The crossing was not for the faint of heart, or stomach. Strong winds and long rollers, made for a rollercoaster-like passage.





Easing up the "pain at the gas pump"!

Here are some tricks to help get your money's worth when you fill up...

1. Fill up your vehicle in the morning when the ground temperature is coolest.

Service station storage tanks are buried below grade; the colder the ground, the denser the gasoline. Gasoline expands with rising temperatures, so if you fill up in the afternoon or evening, you will be pumping less than a true gallon.



In the petroleum business, the specific gravity and temperature of fuel (gasoline, diesel, jet fuel, ethanol and other petroleum products) is significant. Every truckload is temperature-compensated to indicate gallonage is true to the amount pumped. Service stations don't have any temperature compensation adjustment at the pump.

- 2. Don't buy gas if a tanker truck is filling the station's tank. Dirt, and sludge at the bottom of the service stations underground tank is being stirred up. You could transfer that sediment to your vehicles tank.
- 3. Gasoline evaporates very quickly, especially if it's warm. Fill up when your gas tank is half-full (or half-empty). The more gas you have in your tank the less surface liquid is exposed to air; less evaporation from your tank. (Gasoline storage tanks use an internal floating 'roof' membrane to act as a barrier between gasoline and the atmosphere to minimize evaporation.)
- 4. The gas trigger has three delivery settings: slow, medium and high. Don't squeeze the trigger to the highest setting. The high flow agitates the gasoline being pumped as well as agitating the gas in your tank causing a high level of evaporation. You effectively lose gas while you are pumping. (Hoses at the pump are corrugated inside to recover evaporation loss.) Pumping slowly creates less fuel loss due to evaporation.

Hope this helps ease the 'pain at the pump'...

New Porsche Cayenne GTS Debuts at the IAA in Frankfurt

Cayenne SUV Gets Sports Car Upgrades

ATLANTA, SEPTEMBER 7, 2007 -

Porsche underlines the real sporty edge of its successful Cayenne series with the addition of a new model to be unveiled at the Frankfurt International Auto Show next week and going on sale in 2008: the Cayenne GTS boasts a specially developed chassis with permanent all-wheel drive, a V8 engine that offers a sizeable increase in horsepower and for the first time in North America will be available with a six-speed manual transmission.

With its lowered body, the new Cayenne GTS reveals a distinctive front and rear look combined with striking wheel-arch extensions that provide plenty of space for the standard 21-inch alloy rims with 295/35 R21 tires. Redesigned front and rear seats reflect the sportier personality of the new model. Two new paint finishes will be introduced with the Cayenne GTS: Nordic Gold Metallic and GTS Red.

In the United States and Canada the Cayenne GTS will come with Porsche Active Suspension Management (PASM), an electronically controlled damping system and complete with air suspension as standard.

The 2009 Cayenne GTS is scheduled to make its North American debut in March of 2008 at a U.S. price of \$69,300.

Porsche Cars North America, Inc. (PCNA), based in Atlanta, GA, and its subsidiary, Porsche Cars Canada, Ltd., are the exclusive importers of Porsche sports cars and Cayenne sport utility vehicles for the United States and Canada.
