

September 2016 sales are up 1.2 percent compared to the same month last year. The Macan continues to lead in volume with 1,998 vehicle sales, a 72.2 percent increase over September 2015. Year-to-date retail sales stand at 40,246 vehicles, up 2.4 percent compared to last year. Macan deliveries are up 30 percent year-to-date.

Porsche Approved Certified Pre-Owned vehicle sales in the United States were 1,336 for September 2016, an increase of 9.1 percent compared to September 2015. CPO sales year-to-date stand at 12,528 units, a 17.7 percent increase compared to the same period in 2015.

Social time and technical demonstration combine for a great evening at the Auto Clinic

Twenty-six region members enjoyed a tech session Oct. 4 when owner Gordon Skog once again opened his Neenah Auto Clinic shop to the region.

Gordon and Josh Skog supplied the snacks, Dominos pizza, domestic and imported beers and soda. There were also many Snap-On door prizes and a cool special raffle prize. Also, thanks to Pat Quinn, for bringing a variety bucket of iced beer for the group to try, and for his donation of a \$20 gift certificate to Mackinaws as another door prize raffle. Thanks guys!

John Strublic went home with the special raffle prize: a multi-drawer, ball bearing guide roller tool cabinet / cart that we'd all like to have.

Announcements: Be sure to watch the newsletter for upcoming events like the Nov. 1 dinner meeting at Mackinaws and the Holiday Party on Dec. 10. Program: Gordon gave an overview of the many classic cars in his shop.

Before delving into the brake bleed and replacement, Gordon also covered cleaning of the Mass Air Flow sensor. The sensor tells the car's computer the quantity of intake air the engine is consuming in order to adjust the fuel delivery. The small sensing wires in the sensor can be contaminated with dirt, oil from K&N type air filters, or oxidation can cause a car to lose peak performance. A simple and inexpensive spray from an aerosol can of Mass Air Filter cleaner and gentle drying can correct this.

Then on to the evening's tech stuff --it was 911 front brake night at Auto Clinic.

Brakes should always be replaced in pairs – both front and/or both back at the same time. Rubber hoses vs. premium braided stainless steel lines were addressed.

The OEM Zimmerman rotors Gordon uses had a special gray coating on them and didn't need extensive cleaning prior to installation like bare steel rotors which are typically coated with oil from the factory. The grey coating will wear away as the brake pads seat. It also keeps the rotors looking nice longer. He also pointed out that the fins in the rotors were directional so pay attention when installing.

On the 911, the presence and type of brake wear sensors your car has is necessary to help determine what type of brake pad configuration you need to order.

On his sample, the '87 911 had a stuck caliper piston, so he was going to replace it with an OEM ATE caliper rather than go through the labor of rebuilding the old one. They're a little tricky to rebuild because they have caliper pistons on BOTH sides, as opposed to most typical cars with moving pistons only on one side.

As to the brake fluid, Gordon likes to use Castrol synthetic brake fluid and suggests it gets flushed every couple of years. Since brake fluid absorbs moisture from the atmosphere, it's good insurance to prevent corrosion. Even with a professional shop, Gordon chooses to use smaller containers of brake fluid to keep stock fresh with less moisture contamination. Clean fluid will be clear.

A helpful hint from the group was when flushing fluid to alternate two different colors of brake fluid so you can see when the older fluid has all been pumped out and replaced. ATE makes blue and gold for this purpose, or just flush till the fluid looks clean and clear.

Stephenson, Garrity win awards at 2016 Milwaukee Concours d' Elegance in 356 class

In last month's Whaletales we profiled Gordon and Joshua Skog's 356, which competed for judges' attention at the 2016 Milwaukee Concours d'Elegance.

Two additional Fox Valley Region members also had 356s in that class competition — Jim Stephenson and Dennis and Susan Garrity.

Both members won Awards of Excellence in the 356 class. Whaletales asked both to tell us about their cars.

Here's **Jim Stephenson's** story:

Most of you know me for my 1956 red Porsche Speedster that I have owned for about 20 years. I had restored the Speedster a dozen years ago and I was getting a bit bored just polishing on the Speedster. As luck or maybe fate would have it in September of 2007, I was talking with fellow club member Bud Anderson about an old Porsche he had. After talking with him about this old Porsche I became the new owner of the car a few days after speaking with him.

My good friend Greg Russo, now deceased, went up to Bud's with me and we picked up the car as well as a pickup truck full of parts. After getting the car home, and going through the piles of parts and looking at serial numbers, and doing much research, I

was pleasantly surprised to confirm that the engine and transmission were all numbers matching to the car as original.

I then spent probably 20 hours a week on the restoration and research through the completion of the car in the spring of 2016. I try to do as much of the work as I can myself, but I'm not a body guy, so Dave Zimmer at Paintwerks in West Bend did the body and paint work. I also had help from others like Vic Skirmants on the transaxle, The Auto Clinic on assembling the short block, Auto Bahn Interiors, and many other sources too numerous to mention. I wanted the car to be restored just as the factory had delivered it new 1959, so I feel I achieved what I set out to do.

History of the car:

This Model 356A Super painted in silver metallic with green interior with green corduroy front seat inserts was completed by the Porsche factory on July 10, 1959. It came with a sun roof and Stuttgart Blaupunkt radio. The car was delivered to Guerin, Portugal, with the first owner being Carlos Vilhena. The car was first registered Oct. 8, 1959, in Portugal with plate number CI-82-04. The original plates came with the car, so I have used them for shows.

At sometime probably in the mid '70s, the car worked its way over from Portugal to the United States. Then the car was purchased in the late '70s by Fred Hein of Chilton, Wis. Fred began the restoration; then in the spring of 1982, Fred put the car up for sale as an unfinished restoration project. Bud Anderson from Green Bay then purchased the car from Fred. I purchased the car from Bud in 2007 as a major uncompleted project. I figured I would be just the guy to finish the project. I don't know much about the car's time in Portugal, but I suspect the car may have been used for rally use because I've noticed multiple wires and relays set up for lighting and Portugal is well known for rallying. I have been working closely with a contact in Portugal trying to locate history on the car.

The Final Chapter:

I've taken the car out for judged shows three times this year since recently completing the restoration . First off, in mid-July at the WeatherTech International Challenge in Elkhart Lake, Wis., winning the Reserve Award. Next, I was invited to attend the Milwaukee Concours d'Elegance in August winning an Award of Excellence, and lastly, on Labor Day weekend, competing in the Chicago region P.C.A. concours, scoring 304.2 points out of 306 points, in the full concours class. It's been a fun journey, and I look forward to enjoying the car as it was made.

Dennis and Susan Garrity are the fourth owners of a 1956 Speedster. Only about 4,000 Speedsters were built during its run of 1954 through 1958, of which only 1,233 were "Pre-A" cars. Today, the Speedster is the best known and most popular of the Porsche 356 model range. Its styling evokes images of classic open



sports car touring of the 1950s at its best, and visions of sports car enthusiasts like James Dean swashbuckling down the open road in his beloved Porsches.

With the body by Reutter, this is a rare example of a pre-A 356 Speedster. Later models were designated A, B, or C.

It was one of the last four "pre-A" Speedsters built. The car is particularly interesting in that it is one of the very few "pre-A" Speedsters designated as a 1956 model and equipped with the all-new 1600cc engine, all as attested to by the Porsche Factory "Certificate of Authenticity."

The vehicle bears its original matching numbers drivetrain, colors and options. With its iconic Porsche white finish over black interior with contrasting white piping, matching white wheels and original tools and jack, it presents itself as a superb and historic example of the famed Porsche "Speedster" line.

As noted, the Garritys are the fourth owners of the Speedster, having acquired it in 2000 from its third owner, Jim Johnston. Johnston owned the car for 20 years, having purchased it in Long Island, N. Y., from Paul Pfeiffer, a professional Porsche mechanic, in 1980.

Paul Pfeiffer had purchased the car in the mid-1960s from the first owner. The car had been driven extensively throughout the first years of its life, but it was in superb condition at acquisition. The original owner

was in a financial predicament and was reluctantly selling the car, when Paul bought it. It had most all of its original components and had been extremely well cared for.

Paul Pfeiffer was a Porsche lover. Throughout his ownership until sale to Jim Johnston in 1980, Paul and wife Susan continued to use the car on a regular basis, taking it on long drives, club rallies, road races and hill climbs. He said it performed fantastically throughout his ownership and, being a mechanic with expertise in Porsches, he endeavored to keep it running perfectly, stored inside and cared for properly at all times. Some unforeseen circumstances in his life resulted in the necessity of him selling it in 1980 to Jim Johnston.

At that time, Jim lived in New York. He moved to California a few years prior, but kept the car registered in New York, so as to preserve his personal plate of "SPEEDSTR". Johnston owned many Porsches over the years, but had wanted a great Speedster and found it when he saw Pfeiffer's ad offering a "mint condition" Speedster in 1980.

Johnston was meticulous with the car for the 20 years of his ownership. He drove it regularly but never in any rain, snow or adverse weather. It was never left out in the sun. When he was done driving it, he washed it, and stored in inside under a cover. It has never been painted during his ownership or thereafter.

Since the paint is superb on this car, it bears testimony to Johnston's practice of protecting the finish from bad weather and sun, and waxing it regularly. Johnston prided himself on keeping the car as beautiful as when he bought it; the car received routine maintenance while Johnston owned it. The oil was changed at least annually.

In 1991, Johnston moved to California from New York. The car remained stored in New York, and he then had it shipped to California in 1995, and placed in storage in Santa Monica.

The storage was not convenient to his home, and as he grew older, he decided that it was time to sell the Speedster, and in 2000 Dennis and Susan Garrity acquired it in Monterey, Calif.

Board notes from 10/1/2016 meeting of the Fox Valley-PCA region

Attendance: Todd, Jim Haen, Mary, Matt, Jim Janes, Dan, Gordon,

Todd called the meeting to order at 2:10 p.m.

Notes from the April board meeting were reviewed and approved by Dan and seconded by Matt.

Treasurer's report was distributed and motioned for approval by Matt and seconded by Mary.

Bev Jurkowski will take over publication of the FVR PCA Whalestales newsletter beginning Oct. 1. She is also the newsletter editor of Steinlifters for the Milwaukee Region.

Todd will look into the cost of obtaining and utilizing the same advanced software that Mark Wilkinson used to publish Whalestales in the past.

Per PCA National, our Facebook Page is not set up optimally. Once properly set up, it would include multiple administrators. The thought was that the current elected board members would share administration duties. Jim Janes made a motion to look into Erik Scharinger's interest in becoming the FVR PCA Region Facebook Page administrator. Erik has experience as he already moderates for another forum. Matt seconded the motion.

A notice was sent to the general membership asking for interest in running for the 2017 Board of Directors. As of 10-1-16, no one has stepped forward. All current elected Board Members have agreed to run for 2017. Dan agreed to continue as Technical Chair. Gordon agreed to continue as Social Chair and would be interested in mentoring a co-chair. Jim Haen has agreed to continue as librarian/archivist.

Frequency of club sponsored events was discussed. How many events are too many vs. how many are too few? Board consensus was one to two events a month were best. Jim Haen will look to see what he has from past contact fliers and forward to Todd.

Jim H will also forward the information he has for club logo embroidery to Todd. Pre-ordering shirts for large events would be considered on a prepaid basis.

Matt made a motion that we offer a free, one-year PCA membership for those purchasing a Porsche from Bergstrom. This would be for first time members and Not for a current member buying another Porsche. The motion was seconded by Jim Janes. We hope Bergstrom will be agreeable to offering this to their customer on our behalf.

Bob Dean, Dealer Liaison, has done a wonderful job of reviewing and reporting on new models that Bergstrom has received. We hope he has many more to report on.




